Reminders on 2024 HKDSE Results Release Day

1. Release of Examination Results

- (i) All students are to be seated in the school hall before 8:05 am for final reminders.
- (ii) Students may receive the Result Notice from class teachers in the assigned venues (6A – Room 204, 6B – Room 205, 6C – Room 206, 6D – Room 207) by **8:30 am**.
- (iii) Students are encouraged to seek teachers’ guidance advice, whenever the needs arise, in the venues for results release and also CR2.
- (iv) Parents may stay in the school hall while awaiting the results of their children.

2. Application for Rechecking/Remarking of Results

- (i) Students may apply for rechecking and/or remarking for up to a total of **four** subjects.
- (ii) Students may submit only **one** application. Multiple applications will **not** be offered.
- (iii) Applications are processed on a subject basis only in **Rechecking** of Results. Scripts and score sheets are rechecked for technical errors such as arithmetical errors, incorrect markentries and unmarked pages.
- (iv) Applications are processed on a subject basis only, except for Chinese Language and English Language in **Remarking** of Results. For Chinese Language and English Language, applications may be made on a subject or component basis, but the remarking on a subject basis includes the written papers only. For applications for remarking of a subject component, the scripts and score sheets of other components of that subject will also be rechecked for technical errors but not remarked; Remarking for one or more components of a subject is counted as one subject; For Mathematics, applications can be made for remarking either the Compulsory Part or Extended Part, or both (if applicable), as a single subject. Applying for rechecking and remarking of the same subject(s) is not allowed.
- (v) The relevant fees are as follows:

- (vi) Upon successful submission of application through school, students will receive from the HKEAA an acknowledgement with the **demand note** via their registered email. (Students should check and confirm if the email addresses they provided during registration are correct and valid, and inform the school promptly if any changes are required.) Students are reminded to check the acknowledgement sent to their registered email address during the application period. If they have not received the email, they should contact the school immediately.
- (vii) Students should bring along with the Demand Note to any 7-Eleven store or Circle K Convenience Store in Hong Kong and settle the payment of total application fee shown on the Demand Note, by **cash**, on or before the due date (i.e. **within 2 calendar days** upon online submission via school).
- (viii) All rechecking/remarking applications should reach **Mr. Chow Kai-chi** in the staff room on 4/F not later than **4:00 pm on 22 July 2024 (Monday)**. Late applications will not be processed.

4. JUPAS – Modification of Programme Choices

- (i) Students are reminded to modify their study programme choices, if necessary, via their JUPAS account during their allotted 24-hour time slots during the period 18 July – 20 July 2024. You can submit your request only **once**. No fee will be charged.

[Notice that the JUPAS online application system will be closed temporarily during 3:00 am to 6:00 am daily for system maintenance.]

- (ii) Students may revise their lists of study programme choices during the allotted time-slot **once** in any of the following options:
- REPLACE up to 5 programme choices on the programme choice list with new programmes / ADD a maximum of 5 new programmes to the original programme choice list (as long as the total number of programme choices does not exceed 20)
 - CHANGE the preference order of the programme choices
 - DELETE programmes from the programme choice list
- (iii) Students may get access to computer facilities and support to facilitate their submission of requests via their JUPAS account in CR2 during the period 17 July (9:00 am) – 19 July (4:00 pm) 2024.
- (iv) Students who have upgraded HKDSE result(s) in overall level(s) can submit a request for reconsideration of their application via their JUPAS account on **15 August 2024 (9:00 am – 6:00 pm)**, regardless of whether they have been made an offer or have accepted an offer in the Main Round or not.
- [Students SHOULD accept the Main Round offers while their requests for reconsideration of application are pending.]*
